AN ACT concerning

Zoning Regulations – Indoor Shooting Range

FOR the purpose of amending the Baltimore County Zoning Regulations in order to permit an indoor shooting range in the Red Run Employment Corridor of the Owings Mills Growth Area, in the M.L. Zone, as a matter of right, subject to certain conditions and limitations; defining terms; providing parking requirements for an indoor shooting range; and generally relating to indoor shooting ranges in the M.L. Zone.

BY adding

Section 101.1, the definition of Indoor Shooting Range, Alphabetically, and Section 253.1.C.33 and Section 409.6.A.4, Indoor Shooting Range, alphabetically Baltimore County Zoning Regulations

- A. General requirements. The standards set forth below shall apply in all zones unless otherwise noted. If the required number of off-street parking spaces is not set forth for a
- particular type of use, the Director of Permits, Approvals and Inspections shall determine the
- basis of the number of spaces to be provided. If the number of spaces calculated in accordance
- with this section results in a number containing a fraction, the required number of spaces shall be
- the next highest whole number.
