AN ACT concerning

The 2017-2018 ~~Current Expense~~ Capital Budget

Renovations

FOR the purpose of amending the 2017-2018 ~~Current Expense~~ Capital Budget, by  
appropriating to the ~~Gifts and Grants Special Revenue Fund~~ monies derived from private  
funds and made available to the County through the Estate of Clara Louise Linthicum.

WHEREAS, the estate of Clara Louise Linthicum has made an award of private funds  
available to the Baltimore County Department of Recreation and Parks, to be used for the  
funding of the playgrounds in western Baltimore County; and

WHEREAS, in accordance with Sections ~~306 and 712(a)~~ Section 716 of the Baltimore County Charter and ~~Section 10-6-102 of the Baltimore County Code, 2015, as amended,~~ the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

~~WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year~~ may, upon recommendation of the County Executive, amend the Capital Budget; now therefore

1           SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by ~~Sections 306~~  
3 ~~and 712(a)~~ Section 716 of the Baltimore County Charter and ~~Section 10-6-102 of the Baltimore~~  
4 ~~County Code, 2015, as amended,~~ that the ~~Current Expense~~ Capital Budget for the fiscal year  
5 ending June 30, 2018, be and is hereby amended by appropriating private funds made available  
6 to the Baltimore County Recreation and Parks, in the amount herein specified, to the following  
7 program:

9           SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by  
10 the affirmative vote of five members of the County Council, shall take effect March 18, 2018.
