## AN ACT concerning

Zoning Regulations - Cold Rolling Mill

FOR the purpose of permitting a cold rolling mill in the M.L. Zone, if it is located in an I.M.

District; defining certain terms; providing certain restrictions and requirements; and

generally relating to cold rolling mills in M.L. zones.

BY repealing and re-enacting, with amendments

Section 101 – Definitions, the definition of Cold Rolling Mill and Hot Rolling Mill, Alphabetically Baltimore County Zoning Regulations, as amended

#### BY adding

Section 253.1.C.33 Baltimore County Zoning Regulations, as amended

1	SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2	COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

7	COLD ROLLING MILL – A METAL MANUFACTURING AND
8	PROCESSING FACILITY WHERE METALS OR METAL ALLOYS ARE HEATED AND
9	ROLLED TO PRODUCE A METAL OR METAL ALLOY PRODUCT IN FINISHED COIL
10	FORM. THE HEATING FACILITIES AND FURNACES USED ARE CAPABLE OF
11	PRODUCING TEMPERATURES NO GREATER THAN 500 DEGREES CELSIUS.
12	HOT ROLLING MILL – A METAL MANUFACTURING AND PROCESSING
13	FACILITY WHERE METALS OR METAL ALLOYS ARE HEATED AND ROLLED TO
14	PRODUCE A METAL OR METAL ALLOY PRODUCT IN COIL FORM. THE HEATING
15	FACILITIES AND FURNACES USED ARE CAPABLE OF PRODUCING TEMPERATURES
16	IN EXCESS OF 500 DEGREES CELSIUS.

19	Manufacturing, Light (M.L.) Zone Use Regulations
20	§ 253.1. Uses permitted as of right.
21	The uses listed in this section, only, shall be permitted as of right in M.L. Zones, subject
22	to any conditions hereinafter prescribed.
23	C. The following auxiliary retail or service uses or semi-industrial uses, provided that
24	any such use is located in a planned industrial park at least 25 acres in net area, in an I.M.
25	District, or in combination of an A.S. and I.M. District:

1	33. COLD ROLLING MILL, IF LOCATED IN AN I.M. DISTRICT.

3	SECTION 2. AND BE IT FURTHER ENACTED, that this Act having been passed by
4	the affirmative vote of five members of the County Council, shall take effect on April 16, 2018.
