- SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
- 2 COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

6	21. A CONSTRUCTION OR CONTRACTOR'S EQUIPMENT STORAGE
7	YARD LESS THAN 4 ACRES IN NET AREA, IN CONTINUOUS OPERATION AS A
8	CONSTRUCTION OR CONTRACTOR'S EQUIPMENT STORAGE YARD FOR MORE
9	THAN FOUR YEARS, AND EXISTING PRIOR TO 2016 MAY CONTINUE TO OPERATE

11	ZONE. THE AREA WITHIN 75 FEET OF AN ADJOINING RESIDENTIAL PROPERTY

13	SCREENING AND LANDSCAPING. THE LOADING, UNLOADING, SORTING, AND
14	TEMPORARY STORAGE OF DISMANTLED BUILDING MATERIALS FROM THE
15	CONSTRUCTION OR CONTRACTOR'S OPERATION, WHETHER INSIDE OR OUTSIDE
16	OF AN ENCLOSED BUILDING, SHALL BE PERMITTED AND NOT BE CONSIDERED A
17	RECYCLING OPERATION. SECTION 1B01.1.B.1 (RESIDENTIAL TRANSITION AREA)
18	REQUIREMENTS SHALL NOT APPLY.

20	SECTION 2. AND BE IT FURTHER ENACTED, that this Act shall take effect 45
