## A BILL ENTITLED

## AN ACT concerning

The 2019 Current Expense Budget
Gifts and Grants Special Revenue Fund
FEMA Assistance to Firefighters Grant Award – Bariatric Medic Units

FOR the purpose of amending the 2019 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds made available to the County through the Assistance to Firefighters Grant from the United States Department of Homeland Security, Federal Emergency Management Agency (FEMA).

WHEREAS, FEMA has made an award of federal funds available to the Baltimore County Fire Department, to be used to for the purchase of three (3) bariatric medic units, replacing three (3) in the current fleet; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the

County Council may accept gifts and grants, appropriate same to the Gifts and Grants

Special Revenue Fund and expend the same, said fund having been established solely for
the purpose of account for certain monetary gifts and grants made available to the County
for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore
