A BILL
ENTITLED

AN ORDINANCE concerning authorization of the issuance, sale and delivery by Baltimore County, Maryland (the "County") of its (i) general obligation consolidated public improvement bonds in the maximum aggregate principal amount of \$350,000,000, (ii) general obligation metropolitan district bonds in the maximum aggregate principal amount of \$250,000,000, (iii) general obligation bond anticipation notes in anticipation of the issuance of such bonds in the maximum aggregate principal amount equal to the maximum aggregate principal amount of such bonds, provided that the aggregate principal amount of the bond anticipation notes issued and outstanding at any one time pursuant to the authority hereof, together with any bond anticipation notes issued and outstanding pursuant to the authority of any other ordinance of the County heretofore enacted, shall not exceed \$600,000,000 and (iv) general obligation refunding bonds in an aggregate principal amount not to exceed 130% of the aggregate principal amount of the bonds authorized to be refunded; and the determination of various matters relating to the authorization, issuance, sale and delivery of such bonds and notes.

FOR the purpose of authorizing and empowering the County to issue, sell and deliver general obligation bonds (i) authorized by the provisions of Bill Nos. 29-12 and 28-14 enacted by the County Council of Baltimore County, Maryland (the “County Council”) in an aggregate principal amount not to exceed \$40,000,000 for the purpose of providing funds for public works, including the construction, improvement and repair of public roads, streets, highways, sidewalks, bridges, viaducts, grade crossings and storm water drainage systems, in the County, (ii) authorized by the provisions of Bill Nos. 27-14 and 31-16 enacted by the County Council in an aggregate principal amount not to exceed \$10,000,000 for the purpose of providing funds for the acquisition, construction, alteration and maintenance of capital and other improvements for community college projects in the County, (iii) authorized by the provisions of Bill Nos. 31-12, 30-14 and 28-16 enacted by the County Council in an aggregate principal amount not to exceed \$5,000,000 for the purpose of providing funds for parks, preservation and greenway projects in the County, (iv) authorized by the provisions of Bill No. 26-14 enacted by the County Council in an aggregate principal amount not to exceed \$5,000,000 for the purpose of providing funds for the acquisition, construction and improvement of refuse disposal facilities, including the acquisition of sites therefor and the acquisition and installation of necessary equipment and facilities therefor, (v) authorized by the provisions of Bill Nos. 31-14 and 33-16 enacted by the County Council in an aggregate principal amount not to exceed \$260,000,000 for the purpose of providing funds for the construction, acquisition and improvement of public school projects in the County, (vi) authorized by the provisions of Bill Nos. 31-10, 33-12 and 32-14 enacted by the County Council in an aggregate principal amount not to exceed \$5,000,000 for the purpose of providing funds for the purchase of land, development rights, conservation easements and other real property pursuant to the Maryland Agricultural Land Preservation Program and the purchase of development rights

as authorized by Section 12-902 of the Local Government Article of the Annotated Code of Maryland (the “Local Government Article”) and related purposes, and (vii) authorized by the provisions of Bill Nos. 30-12 and 29-14 enacted by the County Council in an aggregate principal amount not to exceed \$25,000,000 for the purpose of providing funds for operational buildings, including general, health, police, fire and jail buildings or facilities and necessary or desirable equipment, in the County; providing that such general obligation bonds may be serial maturity or term bonds and may be consolidated into a single series of bonds pursuant to Section 19-101 of the Local Government Article; authorizing and empowering the County to enter into agreements to purchase development rights pursuant to Section 12-902 of the Local Government Article for up to \$5,000,000 which shall constitute general obligations of the County; providing that the aggregate principal amount of general obligation bonds authorized to be issued pursuant to this Ordinance pursuant to Bill Nos. 31-10, 33-12 and 32-14 shall be commensurately reduced by an amount equal to the aggregate principal amount payable under such purchase agreements entered into pursuant to Section 12-902 of the Local Government Article; authorizing and empowering the County to sell bonds and notes to the Maryland Water Quality Financing Administration pursuant to Sections 9-1601 through 9-1622, inclusive, of the Environment Article of the Annotated Code of Maryland which shall constitute general obligations of the County; authorizing and empowering the County to issue, sell and deliver an aggregate principal amount not to exceed \$250,000,000 of serial maturity or term bonds under the provisions of Chapter 539 of the Acts of the General Assembly of Maryland of 1924, as amended, Section 10-203 of the Local Government Article and the Baltimore County Charter (the “County Charter”) for the purpose of providing funds for meeting the expenses of the County for design and construction, purchase or acquisition of the water supply, sewerage and drainage systems provided for by Article 20 of the

Baltimore County Code (2015 edition, as amended and supplemented); providing that the County Executive of the County (the “County Executive”) shall determine all matters relating to the sale, issuance, delivery and payment of all bonds and notes issued pursuant to this Ordinance, subject to and in accordance with the provisions of this Ordinance; prescribing certain of the terms, conditions, form and tenor of bonds; prescribing certain of the terms and conditions for the sale of bonds (other than refunding bonds) at public sale at such price as shall be determined by the County Executive, which may be at, above or below par; authorizing the preparation, printing, execution and delivery by the County of a Preliminary Official Statement and an Official Statement or other offering document with respect to bonds and notes issued pursuant to this Ordinance; providing for the levy and collection of all taxes, charges and assessments necessary for the payment of the principal of and interest on all bonds and notes issued pursuant to this Ordinance and any installment purchase agreements when due; authorizing and empowering the County, upon its full faith and credit, to issue, sell and deliver its bond anticipation notes in anticipation of the issuance and sale of such bonds in an aggregate principal amount not to exceed the aggregate principal amount of bonds authorized to be issued under this Ordinance; providing that the aggregate principal amount of the bond anticipation notes issued and outstanding at any one time pursuant to the authority hereof, together with any bond anticipation notes issued and outstanding pursuant to the authority of any other ordinance of the County heretofore enacted, shall not exceed \$600,000,000; providing that such bond anticipation notes shall be sold at private (negotiated) or at public sale for a price at, above or below, the par value thereof, as may be determined by the County Executive; providing that such bond anticipation notes may be issued as variable rate demand obligation notes in the nature of commercial paper or other similar obligations and, in such event, authorizing the County Executive to determine various matters and to take various other

actions in connection therewith; covenanting to issue the bonds in anticipation of which any such bond anticipation notes are issued as soon as the reason for deferring the issuance thereof no longer exists; covenanting to pay the principal of and interest on any such bond anticipation notes with the proceeds of the bonds in anticipation of the sale of which such bond anticipation notes are issued; providing that the principal of and interest on any such bond anticipation notes may also be paid from the tax revenue or other source of revenue pledged for the repayment of the bonds in anticipation of the sale of which such bond anticipation notes are issued or from the proceeds of other bond anticipation notes issued pursuant to this Ordinance; providing that the proceeds from the sale of bond anticipation notes issued pursuant to this Ordinance may be used to pay the principal or redemption price of and interest on bond anticipation notes previously issued pursuant to this Ordinance; providing that any bond anticipation notes issued to refund bond anticipation notes shall constitute a reissuance of the indebtedness evidenced by the refunded bond anticipation notes; authorizing and empowering the County to issue, sell and deliver, pursuant to Sections 10-203 and 19-207 of the Local Government Article, the County Charter, Chapter 539 of the Acts of the General Assembly of Maryland of 1924, as amended, and certain other authority, general obligation refunding bonds for the purpose of refunding certain outstanding general obligation bonds of the County as set forth on Chart II and Chart III attached to this Ordinance or otherwise; providing that such refunding bonds may be issued in an aggregate principal amount not to exceed 130% of the aggregate principal amount of the outstanding bonds to be refunded; providing that such refunding bonds shall be sold at private (negotiated) or at public sale for a price at, above or below, the par value thereof, as may be determined by the County Executive; providing that any refunding bonds issued to refund bonds authorized by this Ordinance shall constitute a reissuance of the indebtedness evidenced by the refunded bonds; showing

compliance with the limitations on the power of the County to incur indebtedness; authorizing the County to enter into one or more agreements as the County Executive shall deem necessary or appropriate for the issuance, sale, delivery or security of bonds or notes issued pursuant to this Ordinance; providing that to the extent authorized by the County Executive, the County Administrative Officer of the County may make any determination and take any other act authorized to be taken by the County Executive under this Ordinance; and generally determining and providing for various matters relating to the authorization, issuance, sale and delivery of such bonds, bond anticipation notes and refunding bonds.

BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, MARYLAND:

1 SECTION 1. In accordance with the Bills entitled (1) “AN ORDINANCE concerning
2 Public Works Borrowing. FOR the purpose of authorizing and empowering Baltimore County,
3 Maryland to borrow money in a principal amount not exceeding \$55,874,000 for public works
4 purposes, for the class of projects which includes, among other things, streets and highways,
5 bridges and storm drainage systems, to be undertaken in the ensuing fiscal years starting July 1,
6 2013, and to provide that the full amount of such borrowing shall be submitted to a referendum of
7 the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718
8 and Section 705(a) of the Baltimore County Charter,” and (2) “AN ORDINANCE concerning
9 Public Works Borrowing. FOR the purpose of authorizing and empowering Baltimore County,
10 Maryland to borrow money in a principal amount not exceeding \$46,370,000 for public works
11 purposes, for the class of projects which includes, among other things, streets and highways,
12 bridges and storm drainage systems, to be undertaken and to provide that the full amount of such
13 borrowing shall be submitted to a referendum of the registered voters of Baltimore County for

1 their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County
2 Charter,” each duly read and passed by the County Council of Baltimore County, Maryland (the
3 “County Council”), duly presented to the County Executive of Baltimore County, Maryland (the
4 “County Executive”), for his approval, duly approved and enacted, and now fully effective,
5 constituting Bill Nos. 29-12 and 28-14, respectively, enacted by the County Council (hereinafter
6 referred to collectively as the “Baltimore County 2012/14 Public Works Borrowing Plan
7 Ordinances”), and particularly Section 2 of each thereof, the County Council hereby determines
8 that \$40,000,000 is the amount presently estimated to be needed to pay costs of construction,
9 improvement, repair, opening, relocation, grading, resurfacing, widening and extension of public
10 works projects, including (without limitation) roads, streets, highways, sidewalks, storm drain
11 systems, bridges, viaducts, grade crossings, parking lots and structures, dredging, the purchase or
12 other acquisition of land, easements, rights-of-way and any and all other rights and privileges
13 appurtenant thereto, the acquisition of equipment for construction, maintenance and repair and
14 planning, architectural, engineering and other services related to such projects and expenses,
15 including the costs and expenses of printing and advertising, legal fees and other expenses in
16 connection with issuance, sale and delivery of bonds for such purposes.

17 SECTION 2. In accordance with the Bills entitled (1) “AN ORDINANCE concerning
18 Community College Borrowing. FOR the purpose of authorizing and empowering Baltimore
19 County, Maryland to borrow money in a principal amount not exceeding \$15,000,000 for the
20 purpose of community college projects to be undertaken and to provide that the full amount of
21 such borrowing shall be submitted to a referendum of the registered voters of Baltimore County
22 for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County
23 Charter,” and (2) “AN ORDINANCE concerning Community College Borrowing. FOR the
24 purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a
25 principal amount not exceeding \$15,000,000 for the purpose of community college projects to be

1 undertaken and to provide that the full amount of such borrowing shall be submitted to a
2 referendum of the registered voters of Baltimore County for their approval or rejection, pursuant
3 to Section 718 and Section 705(a) of the Baltimore County Charter,” each duly read and passed
4 by the County Council, duly presented to the County Executive for his approval, duly approved
5 and enacted, and now fully effective, constituting Bill Nos. 27-14 and 31-16, enacted by the
6 County Council (hereinafter referred to collectively as the “Baltimore County 2014/16 Community
7 College Borrowing Plan Ordinances”), and particularly Section 2 of each thereof, the County
8 Council hereby determines that \$10,000,000 is the amount presently estimated to be needed to pay
9 costs of acquisition of land, easements, rights-of-way and any and all other rights and privileges
10 appurtenant thereto, the construction, reconstruction, extension, improvement, enlargement,
11 alteration, maintenance, repair, modernization and development of buildings and other
12 improvements for community colleges, architectural, engineering and other services incident
13 thereto and the purchase or other acquisition and installation of furnishings and equipment
14 necessary or desirable therefor, including the costs and expenses of printing and advertising, legal
15 fees and other expenses in connection with issuance, sale and delivery of bonds for such purposes.

16 SECTION 3. In accordance with the Bills entitled (1) “AN ORDINANCE concerning
17 Parks, Preservation and Greenways Borrowing. FOR the purpose of authorizing and empowering
18 Baltimore County, Maryland to borrow money in a principal amount not exceeding \$2,000,000 for
19 the purpose of parks, preservation and greenways projects to be undertaken in the ensuing fiscal
20 years starting July 1, 2013 and to provide that the full amount of such borrowing shall be submitted
21 to a referendum of the registered voters of Baltimore County for their approval or rejection,
22 pursuant to Section 718 and Section 705(a) of the Baltimore County Charter,” (2) “AN
23 ORDINANCE concerning Parks, Preservation and Greenways Borrowing. FOR the purpose of
24 authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount
25 not exceeding \$4,000,000 for the purpose of parks, preservation and greenways projects to be

1 undertaken and to provide that the full amount of such borrowing shall be submitted to a
2 referendum of the registered voters of Baltimore County for their approval or rejection, pursuant
3 to Section 718 and Section 705(a) of the Baltimore County Charter,” and (3) “AN ORDINANCE
4 concerning Parks, Preservation and Greenways Borrowing. FOR the purpose of authorizing and
5 empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding
6 \$4,000,000 for the purpose of parks, preservation and greenways projects to be undertaken and to
7 provide that the full amount of such borrowing shall be submitted to a referendum of the registered
8 voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section
9 705(a) of the Baltimore County Charter,” each duly read and passed by the County Council, duly
10 presented to the County Executive for his approval, duly approved and enacted, and now fully
11 effective, constituting Bill Nos. 31-12, 30-14 and 28-16, respectively, enacted by the County
12 Council (hereinafter referred to collectively as the “Baltimore County 2012/14/16 Parks,
13 Preservation and Greenways Borrowing Plan Ordinances”), and particularly Section 2 of each
14 thereof, the County Council hereby determines that \$5,000,000 is the amount presently estimated
15 to be needed to pay costs of parks, preservation and greenways projects, including the cost of the
16 construction, improvement, alteration, repair, maintenance and equipping of public parks,
17 playgrounds, community centers and recreational buildings and facilities, the acquisition and
18 development of the site therefor, engineering and other services incident thereto and the purchase
19 or other acquisition, installation and maintenance and repair of customary, temporary and
20 permanent appurtenances and recreational facilities and equipment, including the costs and
21 expenses of printing, advertising and legal fees and other expenses in connection with the issuance,
22 sale and delivery of bonds for such purposes.

23 SECTION 4. In accordance with the Bill entitled “AN ORDINANCE concerning Refuse
24 Disposal Borrowing. FOR the purpose of authorizing and empowering Baltimore County,
25 Maryland to borrow money in a principal amount not exceeding \$11,930,000 for refuse disposal

1 projects to be undertaken and to provide that the full amount of such borrowing shall be submitted
2 to a referendum of the registered voters of Baltimore County for their approval or rejection,
3 pursuant to Section 718 and Section 705(a) of the Baltimore County Charter,” duly read and passed
4 by the County Council, duly presented to the County Executive for his approval, duly approved
5 and enacted, and now fully effective, constituting Bill No. 26-14, enacted by the County Council
6 (hereinafter referred to as the “Baltimore County 2014 Refuse Disposal Borrowing Plan
7 Ordinance”), and particularly Section 2 thereof, the County Council hereby determines that
8 \$5,000,000 is the amount presently estimated to be needed to pay costs of construction,
9 reconstruction, extension, acquisition, improvement, enlargement, alteration, closing and capping,
10 repair or modernization of county refuse disposal facilities, including the acquisition and
11 development of sites therefor, the architectural and engineering services incident thereto, and
12 acquisition and installation of necessary equipment and facilities therefor.

13 SECTION 5. In accordance with the Bills entitled (1) “AN ORDINANCE concerning
14 School Borrowing. FOR the purpose of authorizing and empowering Baltimore County, Maryland
15 to borrow money in a principal amount not exceeding \$157,899,000 for public school buildings,
16 buildings for school purposes, buildings to support school operations and site projects to be
17 undertaken and to provide that the full amount of such borrowing shall be submitted to a
18 referendum of the registered voters of Baltimore County for their approval or rejection, pursuant
19 to Section 718 and Section 705(a) of the Baltimore County Charter,” and (2) “AN ORDINANCE
20 concerning School Borrowing. FOR the purpose of authorizing and empowering Baltimore
21 County, Maryland to borrow money in a principal amount not exceeding \$166,000,000 for public
22 school buildings, buildings for school purposes, buildings to support school operations and site
23 projects to be undertaken and to provide that the full amount of such borrowing shall be submitted
24 to a referendum of the registered voters of Baltimore County for their approval or rejection,
25 pursuant to Section 718 and Section 705(a) of the Baltimore County Charter,” each duly read and

1 passed by the County Council, duly presented to the County Executive for his approval, duly
2 approved and enacted, and now fully effective, constituting Bill Nos. 31-14 and 33-16,
3 respectively, enacted by the County Council (hereinafter referred to collectively as the “Baltimore
4 County 2014/16 Public Schools Borrowing Plan Ordinances”), and particularly Section 2 of each
5 thereof, the County Council hereby determines that \$260,000,000 is the amount presently
6 estimated to be needed to pay costs of construction, reconstruction, improvement, extension,
7 alteration, repair, purchase, conversion and modernization of public school buildings or buildings
8 for school purposes, including the sites therefor, the cost of acquiring any such buildings or sites,
9 drainage systems in connection with such sites, architectural and engineering services, including
10 preparation of plans, drawings and specifications for such schools or the conversion or
11 modernization thereof and the development of the grounds, and customary permanent
12 appurtenances and recreation and parks equipment for such schools, including the costs and
13 expenses of printing and advertising, legal fees and other expenses in connection with issuance,
14 sale and delivery of bonds for such purposes.

15 SECTION 6. In accordance with the Bills entitled (1) “AN ORDINANCE concerning
16 Agricultural and Rural Land Preservation Borrowing. FOR the purpose of authorizing and
17 empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding
18 \$5,000,000 for land preservation to be undertaken in the ensuing fiscal years starting July 1, 2011,
19 and to provide that the full amount of such borrowing shall be submitted to a referendum of the
20 registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and
21 Section 705(a) of the Baltimore County Charter,” (2) “AN ORDINANCE concerning Agricultural
22 and Rural Land Preservation Borrowing. FOR the purpose of authorizing and empowering
23 Baltimore County, Maryland to borrow money in a principal amount not exceeding \$1,000,000 for
24 land preservation to be undertaken in the ensuing fiscal years starting July 1, 2013, and to provide
25 that the full amount of such borrowing shall be submitted to a referendum of the registered voters

1 of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of
2 the Baltimore County Charter,” and (3) “AN ORDINANCE concerning Agricultural and Rural
3 Land Preservation Borrowing. FOR the purpose of authorizing and empowering Baltimore
4 County, Maryland to borrow money in a principal amount not exceeding \$2,000,000 for land
5 preservation to be undertaken and to provide that the full amount of such borrowing shall be
6 submitted to a referendum of the registered voters of Baltimore County for their approval or
7 rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter,” each duly
8 read and passed by the County Council, duly presented to the County Executive for his approval,
9 duly approved and enacted, and now fully effective, constituting Bill Nos. 31-10, 33-12 and 32-
10 14, respectively, enacted by the County Council (hereinafter referred to collectively as the
11 “Baltimore County 2010/12/14 Agricultural Land Preservation Borrowing Plan Ordinances”), and
12 particularly Section 2 of each thereof, and in accordance with Section 12-902 of the Local
13 Government Article, the County Council hereby determines that \$5,000,000 is the amount
14 presently estimated to be needed to pay costs of the purchase of land, development rights,
15 conservation easements and other real property pursuant to the Maryland Agricultural Land
16 Preservation Program, the Rural Legacy Program, Section 12-902 of the Local Government Article
17 or other similar federal, State or county programs, as applicable, including the costs and expenses
18 of printing and advertising, legal fees and other expenses in connection with issuance, sale and
19 delivery of bonds or other obligations for such purposes.

20 SECTION 7. In accordance with the Bills entitled (1) “AN ORDINANCE concerning
21 Operational Buildings Borrowing. FOR the purpose of authorizing and empowering Baltimore
22 County, Maryland to borrow money in a principal amount not exceeding \$23,148,000 for public
23 operational buildings, including but not limited to general, health, police, fire, recreation, library,
24 senior center and jail buildings or facilities and necessary or desirable equipment to be undertaken
25 in the ensuing fiscal years starting July 1, 2013 and to provide that the full amount of such

1 borrowing shall be submitted to a referendum of the registered voters of Baltimore County for
2 their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County
3 Charter,” and (2) “AN ORDINANCE concerning Operational Buildings Borrowing. FOR the
4 purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a
5 principal amount not exceeding \$28,500,000 for public operational buildings, including, but not
6 limited to general, health, police, fire, recreation, library, senior center and jail buildings or
7 facilities and necessary or desirable equipment to be undertaken and to provide that the full amount
8 of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County
9 for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County
10 Charter,” each duly read and passed by the County Council, duly presented to the County
11 Executive for his approval, duly approved and enacted, and now fully effective, constituting Bill
12 Nos. 30-12 and 29-14, enacted by the County Council (hereinafter referred to collectively as the
13 “Baltimore County 2012/14 Operational Buildings Borrowing Plan Ordinances”) and particularly
14 Section 2 of each thereof, the County Council hereby determines that \$25,000,000 is the amount
15 presently estimated to be needed to pay costs of construction, reconstruction, extension,
16 acquisition, improvement, enlargement, alteration, repair or modernization of operational
17 buildings, including general, health, police, fire, recreation, library, senior center and jail buildings
18 or facilities and necessary or desirable equipment, the purchase or other acquisition of
19 architectural, engineering and other services incident thereto, the purchase or other acquisition of
20 interests in and to land, easements, rights-of-way and any and all other rights and privileges
21 appurtenant thereto, the purchase or other acquisition and installation of necessary or desirable
22 furnishings and equipment, including (without limitation) firefighting equipment, communications
23 and transmitting facilities and equipment, including the costs and expenses of printing and
24 advertising, legal fees and other expenses in connection with issuance, sale and delivery of bonds
25 for such purposes.

1 SECTION 8. Pursuant to the Baltimore County Charter (the “County Charter”), Sections
2 10-203 and 19-101 of the Local Government Article, and the Baltimore County 2012/14 Public
3 Works Borrowing Plan Ordinances, the Baltimore County 2014/16 Community College
4 Borrowing Plan Ordinances, the Baltimore County 2012/14/16 Parks, Preservation and Greenways
5 Borrowing Plan Ordinances, the Baltimore County 2014 Refuse Disposal Borrowing Plan
6 Ordinance, the Baltimore County 2014/16 Public Schools Borrowing Plan Ordinances, the
7 Baltimore County 2010/12/14 Agricultural Land Preservation Borrowing Plan Ordinances and the
8 Baltimore County 2012/14 Operational Buildings Borrowing Plan Ordinances (such Ordinances
9 being referred to herein collectively as the “Borrowing Plan Ordinances”), the County shall, upon
10 its full faith and credit, borrow money and incur indebtedness in principal amounts not to exceed
11 the maximum principal amount listed in Chart I attached hereto and made a part hereof for each
12 such Borrowing Plan Ordinance, for the purpose of financing projects of the types or classes
13 described in Sections 1 through 7 of this Ordinance. Except as provided in Section 9 of this
14 Ordinance with respect to certain indebtedness incurred pursuant to the Baltimore County
15 2010/12/14 Agricultural Land Preservation Borrowing Plan Ordinances, such borrowing and
16 indebtedness shall be evidenced by separate series of bonds of the County each aggregating not
17 more than the maximum principal amount set forth in Chart I for such purpose, issued, sold and
18 delivered under the authority of and pursuant to the respective Borrowing Plan Ordinances (each
19 such series of bonds being referred to herein individually as an “Individual Series” and collectively
20 as the “Consolidated Public Improvement Bonds”). The bonds of each of the Individual Series
21 may be issued at one time or from time to time and may be consolidated for the purpose of issuance,
22 sale and delivery in one or more series of Consolidated Public Improvement Bonds, as may be
23 determined by the County Executive.

24 Notwithstanding any other provision of this Ordinance, any Bonds or Notes (each as
25 hereinafter defined) authorized by this Ordinance may be sold to the Maryland Water Quality

1 Financing Administration (the “Water Quality Administration”) as further specified in Section 23
2 of this Ordinance.

3 SECTION 9. In lieu of issuing all or any of the Consolidated Public Improvement Bonds
4 authorized by Section 8 of this Ordinance for the purpose of financing projects authorized by the
5 Baltimore County 2010/12/14 Agricultural Land Preservation Borrowing Plan Ordinances, the
6 County may, pursuant to Section 12-902 of the Local Government Article, upon its full faith and
7 credit, borrow money and incur indebtedness under agreements by the County to purchase
8 development rights (each an “Installment Purchase Agreement”).

9 Each Installment Purchase Agreement shall be executed and delivered by the County to
10 effect, together with direct cash payments, where applicable, the purchase by the County of
11 development rights (the “Development Rights Easements”) for the preservation or conservation of
12 agricultural, rural or other land.

13 Properties for which the County intends to purchase Development Rights Easements
14 shall be designated from time to time by resolution of the County Council (each, an “Easement
15 Schedule Resolution”). The Easement Schedule Resolution with respect to each Development
16 Rights Easement to be purchased shall designate (i) the maximum purchase price for such
17 Development Rights Easement, (ii) the maximum principal amount payable under the Installment
18 Purchase Agreement pertaining to such Development Rights Easement and (iii) the provisions,
19 terms, conditions and duration of such Installment Purchase Agreement.

20 The County hereby determines that the incurrence of indebtedness in connection with the
21 purchase by the County of Development Rights Easements is in the public interest.

22 Installment Purchase Agreements, when properly executed and delivered in the manner
23 prescribed for the execution and delivery of bonds in this Ordinance below, shall constitute
24 unconditional general obligations of the County, to the payment of which, in accordance with the

1 terms thereof, its full faith and credit are pledged. Amounts shall not be required to be fully
2 available or encumbered in the fiscal year that the Development Rights Easement under such
3 Installment Purchase Agreement is purchased.

4 In making the determinations described above, the County Executive shall consider the
5 recommendation of the Director of Budget and Finance of the County (the “Director of Budget
6 and Finance”) concerning the terms of each Installment Purchase Agreement, including (without
7 limitation) the determination by the Director of Budget and Finance that the purchase price payable
8 under such Installment Purchase Agreement is not more than the value of the Development Rights
9 Easement based on an appraisal thereof or an estimate approved by the Director of Budget and
10 Finance, taking into account the amount of any cash payment made by the County.
11 Notwithstanding the foregoing, upon the execution and delivery of an Installment Purchase
12 Agreement in accordance with this Ordinance, such Installment Purchase Agreement shall
13 constitute a binding general obligation of the County in accordance with its terms without regard
14 to any determination, dispute or contrary assertion, report or finding regarding the value of the
15 Development Rights Easement or Installment Purchase Agreement or the appropriateness of the
16 terms set forth in such Installment Purchase Agreement.

17 Subject to and in accordance with the provisions of this Ordinance, the County Executive
18 shall determine by order, for each and every Installment Purchase Agreement, all matters relating
19 thereto, including (without limitation) the purposes for which such Installment Purchase
20 Agreement is issued, the prepayment provisions, if any, thereof, the manner of authentication of
21 such Installment Purchase Agreement, if any, the date from which interest on such Installment
22 Purchase Agreement shall accrue, the rate or rates of interest borne by such Installment Purchase
23 Agreement or the method of determining the same, the interest payment and maturity dates thereof,
24 and the provisions for the registration of Installment Purchase Agreements.

1 The County Executive is hereby authorized to determine the form of Installment Purchase
2 Agreements and the execution and delivery thereof shall be conclusive evidence of the approval
3 of the form of such Installment Purchase Agreements on behalf of the County. Installment
4 Purchase Agreements shall be executed by the County Executive, and the seal of the County shall
5 be affixed or imprinted thereon, attested by the Secretary to the County Executive.

6 Installment Purchase Agreements may be sold for a price at, above or below par, plus
7 accrued interest to the date of delivery through a private (negotiated) sale, without solicitation of
8 competitive bids and such sale is hereby determined to be in the best interests of the County.
9 Installment Purchase Agreements are hereby specifically exempted from the provisions of Sections
10 19-205 and 19-206 of the Local Government Article.

11 Notwithstanding the foregoing:

12 (a) Principal payments on Installment Purchase Agreements shall be made on
13 one or more dates as determined by order of the County Executive; and

14 (b) Installment Purchase Agreements shall mature not later than 30 years after
15 the date of their execution and delivery.

16 Following the execution and delivery of any Installment Purchase Agreement, the County
17 Executive, or the Director of Budget and Finance, if authorized by the County Executive, shall
18 report the terms thereof in writing at the next meeting of the County Council.

19 The principal amount payable under each Installment Purchase Agreement executed and
20 delivered by the County pursuant to this Section as specified by the County Executive prior to the
21 execution and delivery thereof shall be treated as indebtedness issued pursuant to the Baltimore
22 County 2010/12/14 Agricultural Land Preservation Borrowing Plan Ordinances for the purposes
23 of determining the amounts of indebtedness that may be issued pursuant to this Ordinance.

1 SECTION 10. In accordance with the authority contained in Chapter 539 of the Acts of
2 the General Assembly of Maryland of 1924, as amended (“Chapter 539”), Section 10-203 of the
3 Local Government Article and the County Charter, the County Council hereby determines that
4 \$250,000,000 is the amount presently estimated to be needed to provide funds for the design,
5 construction, purchase or acquisition of the water supply, sewerage and drainage systems provided
6 for by Article 20 of the Baltimore County Code (2015 edition, as amended and supplemented) (the
7 “Baltimore County Code”), including funds to pay the costs and expenses of printing and
8 advertising, legal fees and other expenses in connection with the issuance, sale and delivery of
9 bonds for such purposes.

10 SECTION 11. Pursuant to Chapter 539, Section 10-203 of the Local Government Article
11 and the County Charter, the County shall, upon its full faith and credit, borrow money and incur
12 indebtedness in an aggregate principal amount not to exceed \$250,000,000 for the purposes
13 described generally in Section 10 of this Ordinance. Such borrowing and indebtedness shall be
14 evidenced by bonds of the County issued, sold and delivered as provided by this Ordinance at one
15 time or from time to time (such bonds being referred to herein collectively as the “Metropolitan
16 District Bonds”).

17 The Consolidated Public Improvement Bonds, Metropolitan District Bonds and Refunding
18 Bonds (hereinafter defined) are sometimes referred to herein collectively as the “Bonds” and
19 individually as a “Bond.”

20 SECTION 12. Subject to and in accordance with the provisions of this Ordinance, the
21 County Executive shall determine by order, for each and every Bond or series of Bonds issued
22 pursuant to and in accordance with this Ordinance, all matters relating to the sale, issuance,
23 delivery and payment of the Bonds, including (without limitation) the purposes for which such
24 Bonds are issued; the allocation of the aggregate principal amount of Consolidated Public

1 Improvement Bonds to the various Individual Series and the Refunded Bonds (hereinafter defined)
2 to be refinanced with proceeds of such Bonds; the date or dates of sale of the Bonds; the
3 designation of the Bonds; the dated date of the Bonds; the authorized denominations for the Bonds;
4 the redemption provisions, if any, pertaining to the Bonds; the manner of authentication and
5 numbering of any Bonds; the date from which interest on the Bonds shall accrue; the rate or rates
6 of interest borne by the Bonds or the method of determining the same; the interest payment and
7 maturity dates of the Bonds, including provisions for mandatory sinking fund redemption of any
8 term bonds, subject to the further provisions of this Section; whether the Bonds are to be issued in
9 book-entry form and all matters incident to the issuance of Bonds in book-entry form; and the
10 provisions for the registration of Bonds. All Bonds issued hereunder shall be made payable (i) in
11 accordance with an annual principal installment plan by the issuance of serial maturity Bonds or
12 term Bonds having mandatory sinking fund requirements, under which principal installments (by
13 way of serial bond maturities or mandatory term bond redemptions) shall commence not more than
14 two years from the date of issue of such Bonds; (ii) within the probable useful life of the
15 improvement or undertaking with respect to which they are issued, as such useful life has been
16 determined in this Ordinance, or, if the Bonds are to be issued for several improvements or
17 undertakings, then within the average probable useful life of all such improvements or
18 undertakings, as such average probable useful life has been determined in this Ordinance, all as
19 required by Section 719 of the County Charter; and (iii) in the case of Refunding Consolidated
20 Public Improvement Bonds and Refunding Metropolitan District Bonds (each as hereinafter
21 defined) on or before the last day of the fiscal year of the County during which the Refunded Bonds
22 to be refunded from the proceeds of such Bonds would have finally matured.

23 SECTION 13. The Bonds, when issued, shall be authenticated by the facsimile or manual
24 signature of the Director of Budget and Finance or an authorized deputy or deputies appointed for
25 such purpose, the appointment of a deputy or deputies for such purpose to be evidenced by a

1 certificate executed by the County Executive or the Director of Budget and Finance, and shall bear
2 the manual or facsimile signature of the County Executive and an original or facsimile of the seal
3 of the County attested by the manual or facsimile signature of the Secretary to the County
4 Executive. The Bonds shall be registered as to principal and interest in the name or names of the
5 owner or owners thereof on books kept for the registration and registration of transfer of the Bonds
6 by the Director of Budget and Finance or a bank or other financial institution designated to act as
7 bond registrar (the "Bond Registrar"). Each Bond shall be authenticated by the manual signature
8 of an authorized signatory of the Bond Registrar except as otherwise provided by order of the
9 County Executive prior to their issuance. No Bonds issued hereunder required to be authenticated
10 shall be valid for any purpose or constitute an obligation of the County unless authenticated as
11 provided herein.

12 In case any official of the County whose signature shall appear on any Bond shall cease to
13 be such official prior to the authentication and delivery of such Bond, or in case any such official
14 shall take office subsequent to the date of any such Bond, his signature, in either event, shall
15 nevertheless be valid for the purposes herein intended.

16 Except as otherwise provided by order of the County Executive with respect to any
17 Refunding Bonds, any Bonds sold to the Water Quality Administration as authorized by this
18 Ordinance and any Bonds sold as Installment Purchase Agreements as authorized by this
19 Ordinance, the Bonds, the authentication certificate thereon, the form of assignment and the
20 certification of the legal opinion thereon shall be in substantially the following forms, with such
21 variations, omissions and insertions as are permitted or required by this Ordinance or as may be
22 deemed necessary or appropriate by the officers executing the same, consistent with this
23 Ordinance, the execution and delivery of any Bonds to be conclusive evidence of the approval of
24 any such variations, omissions and insertions, and all of the covenants and conditions therein

1 contained, including (without limitation) the promise to pay therein contained, are hereby adopted
2 by the County as and for the form of obligation to be incurred by the County as the Bonds:

14 The full faith and credit and unlimited taxing power of the County are hereby irrevocably
15 pledged to the levy and collection of the taxes hereinabove prescribed as and when such taxes may
16 become necessary in order to provide sufficient funds to meet the debt service requirements of the
17 Consolidated Public Improvement Obligations when due. The County hereby solemnly covenants
18 with each of the holders of any Consolidated Public Improvement Obligations to levy and collect
19 the taxes hereinabove prescribed and to take all action as may be appropriate from time to time
20 during the period that any of such Consolidated Public Improvement Obligations remain
21 outstanding and unpaid to provide the funds necessary to pay the principal or redemption price of
22 and interest thereon when due.

23 SECTION 18. As soon as any construction work is undertaken that will be payable from
24 the proceeds of the sale of any Metropolitan District Bonds or Metropolitan District Notes, special

1 assessments and charges shall be duly levied against all property in the Metropolitan District
2 benefited, in each instance in accordance with the authority and in the manner prescribed by
3 Sections 20-3-201 to 20-3-220 of the Baltimore County Code. The principal of or sinking fund
4 installments for and interest on the Metropolitan District Bonds, Metropolitan District Notes and
5 Refunding Metropolitan District Bonds (hereinafter defined) (collectively, the “Metropolitan
6 District Obligations”) that mature or are to be redeemed from mandatory sinking fund installments
7 shall be paid when due from the funds in the hands of the County realized from the levy and
8 collection of such special assessments and charges within the Metropolitan District, including the
9 special assessments and charges levied against property benefited by construction undertaken with
10 the proceeds of the Metropolitan District Obligations (or, in the case of any Refunding
11 Metropolitan District Bonds, with proceeds of the Refunded Bonds refunded with proceeds of such
12 Refunding Metropolitan District Bonds). In the event of a deficiency of such funds at any time
13 while any of such Metropolitan District Obligations are outstanding, for the purpose of meeting
14 such principal, sinking fund installments and interest payments, the County shall promptly levy
15 upon all legally assessable property within the Metropolitan District a tax or taxes in an amount or
16 amounts sufficient to make up any such deficiency, and in the event the proceeds of such tax or
17 taxes so levied shall prove insufficient, then the County shall levy a tax or taxes upon all of the
18 legally assessable property within the entire corporate limits of the County in rate and amount
19 sufficient to provide for payment of the balance of such principal, sinking fund installments and
20 interest as and when due. The full faith and credit and unlimited taxing power of the County are
21 hereby irrevocably pledged to the levy and collection of such special assessments and charges in
22 amounts sufficient for the purpose of meeting, when due, such principal, sinking fund installments
23 and interest payments and also to the levy and collection of the taxes hereinabove prescribed as
24 and when such taxes may become necessary in order to provide sufficient funds to meet the debt
25 service requirements of the Metropolitan District Obligations. The County hereby solemnly

1 covenants with each of the holders of any of the Metropolitan District Obligations to levy and
2 collect the taxes hereinabove prescribed and to take all action as may be appropriate from time to
3 time during the period that any of Metropolitan District Obligations remain outstanding and unpaid
4 to provide the funds necessary to pay the principal or redemption price of and the interest on such
5 Metropolitan District Obligations when due.

6 SECTION 19. The projects listed below are to be financed, in part, from the proceeds of
7 the Consolidated Public Improvement Bonds authorized to be issued and sold by this Ordinance,
8 as such proceeds are allocated to the various Individual Series in accordance with Section 12 of
9 this Ordinance. It is estimated and determined that the aggregate costs of such projects will be no
10 less than \$2,749,355,137, of which \$2,399,355,137 has been or will be defrayed from sources other
11 than the proceeds of Consolidated Public Improvement Bonds hereby authorized, such sources
12 consisting of (a) proceeds of other bond issues in the aggregate principal amount of
13 \$1,393,914,222, (b) contributions by developers and petitioners to the capital costs of certain
14 projects in the aggregate amount of \$29,729,203, (c) federal and State funds in the aggregate
15 amount of \$366,074,260, (d) appropriations from the County General Fund (the "General Fund")
16 in the aggregate amount of \$569,191,222, (e) contributions by other counties and Baltimore City
17 in the aggregate amount of \$154,661, and (f) other miscellaneous sources in the aggregate amount
18 of \$40,291,569. It is hereby estimated and determined that the average period of probable useful
19 life of the projects described below will be in excess of twenty (20) years. A description of the
20 projects, a part of the cost of which will be paid from the proceeds of the Consolidated Public
21 Improvement Bonds, as allocated to the various Individual Series, is as follows:

SECTION 20. The projects listed below are to be financed, in part, from the proceeds of the Metropolitan District Bonds authorized to be issued and sold by this Ordinance. It is estimated and determined that the costs of such projects will be no less than \$2,847,877,965 of which \$2,597,877,965 has been or will be defrayed from sources other than proceeds of Metropolitan District Bonds hereby authorized, such sources consisting of (a) other bond issues in the aggregate principal amount \$2,336,745,277, (b) contributions by developers to the capital costs of certain projects in the aggregate amount of \$2,965,037, (c) federal and State funds in the aggregate amount of \$882,158, (d) appropriations from revenues of the Metropolitan District of the County in the aggregate amount of \$86,018,534, (e) contributions by other counties and Baltimore City in the aggregate amount of \$164,538,847, and (f) other miscellaneous sources in the aggregate amount of \$6,728,112. It is hereby estimated and determined that the average period of probable useful life of the projects described below will be in excess of thirty (30) years. A description of the projects, a part of the cost of which will be paid from the proceeds of Metropolitan District Bonds, is as follows:

2 SECTION 21. It is hereby determined that the outstanding general obligation indebtedness
3 of the County on June 30, 2018 (exclusive of indebtedness issued for self-liquidating and other
4 projects payable primarily or exclusively from the proceeds of the assessments or charges for
5 special benefits or services), plus the \$691,940,000 aggregate principal amount of Consolidated
6 Public Improvement Bonds and Refunding Consolidated Public Improvement Bonds authorized
7 hereby, less the aggregate principal amount of general obligation bonds authorized to be refunded
8 with the proceeds of such Refunding Consolidated Public Improvement Bonds as would be
9 permitted by Section 19-207 of the Local Government Article in the event of the refunding of such
10 general obligation bonds, is equal to \$2,717,067,000. It is hereby determined that the assessable
11 basis of the County on June 30, 2018, was \$84,913,586,015. As of the date of enactment of this
12 Ordinance, the aggregate principal amount of Consolidated Public Improvement Bonds and
13 Refunding Consolidated Public Improvement Bonds authorized to be issued by this Ordinance are
14 within every debt and other limitation prescribed by the Constitution and Laws of Maryland, the
15 County Charter and the Public Local Laws of the County.

16 SECTION 22. It is hereby determined that the outstanding indebtedness incurred to
17 finance the construction and extension of mains, pipes, conduits and lines of various water and
18 sewerage systems located in the Baltimore County Metropolitan District, as defined by law, as of
19 June 30, 2018, plus the \$497,009,500 principal amount of Metropolitan District Bonds and the
20 Refunding Metropolitan District Bonds authorized to be issued and sold as provided for in this
21 Ordinance, less the aggregate principal amount of bonds authorized to be refunded with the

1 proceeds of such Refunding Metropolitan District Bonds as would be permitted by Section 19-207
2 of the Local Government Article in the event of the refunding of such bonds, is equal to
3 \$2,108,064,294. It is hereby determined that the assessable basis of all taxable property within the
4 Baltimore County Metropolitan District on June 30, 2018 was \$75,587,015,531. As of the date of
5 enactment of this Ordinance, the Metropolitan District Bonds and Refunding Metropolitan District
6 Bonds authorized to be issued by this Ordinance are within every debt and other limitation
7 prescribed by the Constitution and Laws of Maryland, the County Charter and the Public Local
8 Laws of the County.

9 SECTION 23. The County is hereby authorized to borrow money and incur indebtedness
10 otherwise authorized to be borrowed and incurred hereinunder in the form of Bonds or Notes by
11 obtaining a loan (a “Water Quality Loan”) from the Water Quality Administration pursuant to and
12 in accordance with Sections 9-1601 to 9-1622, inclusive, of the Environment Article of the
13 Annotated Code of Maryland (the “Water Quality Act”). Any such Water Quality Loan shall be
14 evidenced by a loan agreement (a “Water Quality Loan Agreement”) between the County and the
15 Water Quality Administration and a Bond or Note issued by the County (the Water Quality Loan
16 Agreement and such Bond or Note being referred to herein as a “Water Quality Obligation”).

17 It is acknowledged that the proceeds of any Water Quality Loan will be used for the
18 public purposes of financing a portion of the costs of acquiring, constructing and equipping certain
19 wastewater facilities or water supply systems, each as defined in the Water Quality Act
20 (collectively, the “Water Quality Facilities”) and any related costs, including costs of the Water
21 Quality Administration and the funding of reserves, to the extent permitted by the Water Quality
22 Act. Water Quality Facilities may include projects that the County classifies as wastewater
23 projects, water projects or under some other classification.

1 Subject to and in accordance with the provisions of this Ordinance, the County Executive
2 shall determine by order, for each and every Water Quality Obligation, all matters relating thereto,
3 including (without limitation) the purposes for which such Water Quality Obligation is issued, the
4 prepayment provisions, if any, thereof, the manner of authentication of such Water Quality
5 Obligation, if any, the date from which interest on such Water Quality Obligation shall accrue, the
6 rate or rates of interest borne by such Water Quality Obligation or the method of determining the
7 same, the interest payment and maturity dates thereof; and the provisions for the registration of
8 Water Quality Obligations.

9 The County Executive is hereby authorized to determine the form of Water Quality
10 Obligations and the execution and delivery thereof shall be conclusive evidence of the approval of
11 the form of such Water Quality Obligations on behalf of the County. Water Quality Obligations
12 shall be executed by the County Executive, and the seal of the County shall be affixed or imprinted
13 thereon, attested by the Secretary to the County Executive.

14 Water Quality Obligations may be sold for a price at, above or below par, plus accrued
15 interest to the date of delivery through a private (negotiated) sale, without solicitation of
16 competitive bids and such sale is hereby determined to be in the best interests of the County. Water
17 Quality Obligations are hereby specifically exempted from the provisions of Sections 19-205 and
18 19-206 of the Local Government Article.

19 Notwithstanding the foregoing:

20 (a) annual principal payments on Water Quality Obligations shall begin not more than
21 two years from the date of issue; and

22 (b) Water Quality Obligations shall mature not later than the earlier of 30 years after
23 the date of their execution and delivery or the maximum maturity permitted under the Water
24 Quality Act.

1 Any Water Quality Loan (including any Water Quality Loan Agreement and Water
2 Quality Bond) shall be secured as provided in Sections 17 or 18 of this Ordinance, as applicable.

3 SECTION 24. It is hereby found and determined that an inflexible approach to borrowing
4 by the County threatens its ability to initiate necessary capital projects today and will diminish the
5 resources available to provide for the needs of the citizens of the County in the future, and that the
6 interests of the County are best served by providing the County with reasonable flexibility in
7 accessing the capital markets.

8 In order to provide the County with additional flexibility required in light of current bond
9 market conditions, the County's Financial Advisor has recommended that the County be
10 authorized to refund or otherwise refinance outstanding Bonds authorized hereby in order to effect
11 certain cost savings through the issuance and sale of refunding bonds or other obligations bearing
12 lower interest rates. Because such refinancing would be undertaken to effect cost savings by
13 replacing outstanding Bonds with obligations bearing lower interest rates, it is the intent of the
14 County that such obligations be issued under the Borrowing Plan Ordinances and other authority
15 referred to in Section 8 of this Ordinance or Acts of the General Assembly of Maryland and other
16 authority referred to in Section 10 of this Ordinance, as the case may be, and that such obligations,
17 if issued, will constitute a reissuance of the indebtedness authorized by this Ordinance and shall
18 not constitute additional indebtedness under such authorizations or under any other authority.

19 SECTION 25. Pursuant to Section 19-212(a) of the Local Government Article, the County
20 is hereby authorized to issue and sell its bond anticipation notes (the "Consolidated Public
21 Improvement Notes") in an aggregate principal amount not exceeding \$350,000,000 (subject to
22 the provisions of Section 29 of this Ordinance) in anticipation of the issuance and sale of
23 Consolidated Public Improvement Bonds authorized to be issued and sold under this Ordinance,
24 subject to the provisions of this Ordinance.

1 SECTION 26. Pursuant to Section 19-212(a) of the Local Government Article, the County
2 is hereby authorized to issue and sell its bond anticipation notes (the “Metropolitan District Notes”)
3 in an aggregate principal amount not exceeding \$250,000,000 (subject to the provisions of Section
4 29 of this Ordinance) in anticipation of the issuance and sale of Metropolitan District Bonds
5 authorized to be issued and sold under this Ordinance, subject to the provisions of this Ordinance.

6 Consolidated Public Improvement Notes and Metropolitan District Notes are referred to in
7 this Ordinance collectively as the “Notes.”

8 SECTION 27. Except as otherwise expressly provided in this Ordinance, Notes shall be
9 issued in the same manner as Bonds issued pursuant to this Ordinance and shall have the terms
10 and provisions determined in accordance with Sections 12 and 13 of this Ordinance, and the
11 County Executive is hereby authorized to make the determinations set forth therein with respect
12 to any Notes, as if such Notes were Bonds.

13 All Notes authorized hereby, except Program Notes (as defined in Section 29), shall mature
14 on or before that date which is thirty (30) years after the date of the first Note issued pursuant to
15 this Ordinance (the “Final Maturity Date”).

16 The County Executive is hereby authorized to determine the form of any Notes issued
17 hereunder. The execution and delivery of Notes as herein provided shall be conclusive evidence
18 of the approval of the form of such Notes on behalf of the County.

19 SECTION 28. Notes hereby authorized may be sold for a price at, above or below par,
20 plus accrued interest to the date of delivery. Authority is hereby conferred on the County
21 Executive to sell the Notes through a public sale or through a private (negotiated) sale, without
22 solicitation of competitive bids, as the County Executive, upon consultation with the Director of
23 Budget and Finance and the County’s Financial Advisor, shall determine to be in the best interests

1 of the County. Any sale of Notes hereunder by private negotiation is hereby determined to be for
2 the County's best interest.

3 If the County Executive shall determine in accordance with this Section to sell any Notes
4 at a public sale through the solicitation of competitive bids, then the County Executive may sell
5 such Notes in accordance with such procedures as shall be determined by the County Executive.

6 Notes issued under this Ordinance are hereby specifically exempted from the provisions of
7 Sections 19-205 and 19-206 of the Local Government Article.

8 SECTION 29. It is hereby found and determined as follows: (i) general economic
9 conditions require sensitive and careful debt management in order to reduce to the extent
10 practicable the cost of borrowing to the County and it is in the best interests of the County to be
11 able to implement a flexible approach to borrowing using obligations bearing interest at short-term
12 rates; (ii) there is a large market for obligations bearing interest at short-term rates, such as variable
13 rate demand obligations, commercial paper and other short-term municipal obligations having
14 varying maturities and mandatory and optional redemption, tender or purchase provisions and
15 bearing interest at variable rates based on current market conditions, which may be established by
16 a dealer or remarketing or similar agent, through an auction process or with reference to one or
17 more indices (collectively, "Variable Rate Demand Obligations"); and (iii) the ratings assigned to
18 Variable Rate Demand Obligations and the market for them may be enhanced if there is available
19 to the issuer of Variable Rate Demand Obligations a supporting credit or liquidity arrangement,
20 such as a letter of credit, line of credit or revolving loan agreement (a "Credit Facility"), pursuant
21 to which an alternate source of borrowing will be available during any period in which Variable
22 Rate Demand Obligations cannot be marketed or remarketed, as the case may be.

23 In connection with the issuance by the County of notes having varying maturities and
24 mandatory and optional redemption, tender or purchase provisions and bearing interest at variable

1 rates based on current market conditions, which may be established by a dealer or remarketing or
2 similar agent, through an auction process or with reference to one or more indices (collectively,
3 “Variable Rate Demand Notes”), including (without limitation) Variable Rate Demand Notes in
4 the nature of commercial paper (“Commercial Paper Notes”) or other Variable Rate Demand
5 Obligations, in addition to such Commercial Paper Notes or other Variable Rate Demand Notes,
6 the County is hereby authorized to issue a separate and distinct series of Notes evidencing and
7 securing the obligations of the County under a Credit Facility supporting such Commercial Paper
8 Notes or other Variable Rate Demand Notes, respectively (the “Credit Facility Notes”) (such
9 Commercial Paper Notes or other Variable Rate Demand Notes and such Credit Facility Notes
10 being collectively referred to herein as the “Program Notes”). The word “Notes,” as used in this
11 Ordinance, includes Program Notes, and it is intended that the provisions of this Ordinance
12 applying to Notes shall include Program Notes unless the context clearly requires a contrary
13 meaning.

14 For the purposes of this Ordinance, the term “principal amount” when used with respect to
15 the Program Notes shall mean (i) in the case of any Commercial Paper Note or other Variable Rate
16 Demand Note, the face amount of any such Commercial Paper Notes or other Variable Rate
17 Demand Note, less any original issue discount on such Commercial Paper Note or other Variable
18 Rate Demand Note, and (ii) in the case of any Credit Facility Note, the principal amount actually
19 advanced under a Credit Facility that is evidenced by any such Credit Facility Note. Accordingly,
20 it is contemplated by this Ordinance that the aggregate face amount of Program Notes that may be
21 outstanding from time to time hereunder, together with other Notes issued hereunder and
22 outstanding from time to time, may exceed the aggregate principal amount of Notes authorized to
23 be outstanding hereunder at any one time.

1 It is recognized that the procedures necessary or desirable to implement a commercial paper
2 program within the framework of existing market practices require the County to prescribe
3 procedures to facilitate the prompt determination and approval of certain matters in connection
4 with the authorization, issuance, execution, sale, delivery and payment of and for any Program
5 Notes. Accordingly, the County Executive by or pursuant to executive order or other appropriate
6 action or proceedings is hereby authorized (a) to establish such procedures, including (without
7 limitation) procedures for (i) the determination of the dates, interest payment dates and maturities
8 of any Program Notes, or the method by which the same shall be determined, (ii) the determination
9 of the interest rate or rates to be borne by any Program Notes, which may be separately stated by
10 rate or amount or which may be in an amount equal to the discount thereon, or the method by
11 which the same shall be determined, (iii) any mandatory or optional redemption, tender or purchase
12 dates of Program Notes, and (iv) the determination of the price or prices at which such Program
13 Notes may be sold, which may be at, above or below the face value thereof or the method by which
14 the same shall be determined, and (b) to determine any and all other matters relating to the terms,
15 specifications and form of such Program Notes. Any such procedures may include provisions for
16 telephonic approval and subsequent telegraphic or written confirmation of one or more of such
17 matters by the County Administrative Officer, the Director of Budget and Finance or such other
18 officers or employees of the County as the County Executive shall designate within guidelines or
19 parameters prescribed by the County Executive. The establishment of such procedures and all
20 such determinations and actions shall be deemed to be of an administrative nature.

21 Without limiting the terms and provisions that may be included in any such Notes, to the
22 extent permitted by law and deemed advisable by the County Executive, the full faith and credit
23 and taxing power of the County may be pledged to the payment of the redemption or purchase
24 price of any Program Notes on any date on which such Notes are subject to redemption, tender or

1 purchase at the option of the holders thereof or to mandatory redemption, tender or purchase prior
2 to stated maturity dates.

3 Indebtedness represented by Program Notes issued pursuant to this Ordinance shall be (i)
4 amortized on an annual basis beginning on or before the second anniversary of the date on which
5 the first Program Note is issued hereunder and (ii) finally paid within the probable useful life of
6 the improvement or undertaking with respect to which such indebtedness is originally incurred, or,
7 if such indebtedness is issued for several improvements or undertakings, then within the average
8 probable useful life of all such improvements or undertakings, as such probable useful lives have
9 been determined in this Ordinance. If the principal of any Program Notes issued to finance or
10 refinance any undertaking or undertakings is paid from any source other than from the proceeds
11 of the sale of Notes or Bonds issued hereunder, then the authority to incur indebtedness for such
12 undertaking or undertakings pursuant to this Ordinance and the Borrowing Plan Ordinances and
13 other authority referred to in Section 8 of this Ordinance, or the Acts of the General Assembly of
14 Maryland and other authority referred to in Section 10 of this Ordinance, as the case may be, shall
15 be reduced or exhausted to the extent of such payment of principal.

16 The aggregate principal amount of Program Notes issued and outstanding at any one time
17 pursuant to the authority hereof, together with the aggregate principal amount of any other bond
18 anticipation notes secured by the full faith and credit of the County and issued and outstanding
19 pursuant to the authority of this or any other ordinance of the County heretofore enacted, shall not
20 exceed Six Hundred Million Dollars (\$600,000,000).

21 SECTION 30. The County hereby covenants and agrees with the holders of Notes issued
22 under this Ordinance to issue the Bonds in anticipation of the sale of which such Notes are issued
23 when, and as soon as, the reason for deferring the issuance thereof no longer exists, and to pay the
24 principal of and interest on such Notes from the proceeds of such Bonds. This covenant shall be

1 binding upon the County notwithstanding any limitation set forth in this Ordinance, including
2 (without limitation) any limitation with respect to the interest rate or rates that the Bonds may bear.
3 If the County shall not, for any reason, issue and sell such Bonds as aforesaid, or if the proceeds
4 from the sale of such Bonds shall be insufficient to pay the principal of and interest on any Notes,
5 then the revenues from taxes and other sources intended for application to debt service on such
6 Bonds shall be applied to the payment of the interest on and principal of such Notes. The foregoing
7 provisions shall not be construed so as to prohibit the County from paying the principal or
8 redemption price of and interest on any Note issued hereunder from the proceeds of the sale of any
9 other Note issued hereunder or from any other funds legally available for that purpose.

10 If the County shall not, for any reason, issue and sell any Consolidated Public Improvement
11 Bonds in anticipation of which any Notes are issued, or if the proceeds from the sale of such Bonds
12 shall be insufficient to pay the principal of or interest on such Notes, then the County shall include
13 in the levy in each and every fiscal year that any of such Notes are outstanding, *ad valorem* taxes
14 upon all the legally assessable property within the corporate limits of the County in rate and amount
15 sufficient to provide for the payment, when due, of the principal of and interest on all of such Notes
16 maturing in each such fiscal year; and in the event the proceeds from taxes so levied in any such
17 fiscal year shall prove inadequate for the above purposes, additional taxes shall be levied in the
18 succeeding fiscal years to make up such deficiency. The County may apply to the payment of the
19 principal of and interest on any such Notes any funds received by it from the State of Maryland,
20 the United States of America or any agency or instrumentality thereof, or from any other source,
21 if such funds are granted or otherwise obtained for the purpose of assisting the County in obtaining
22 public facilities of the class or classes of public facilities for which such Notes are authorized; and
23 to the extent that any such funds received or receivable in any fiscal year are applied to such
24 purposes as provided herein, the taxes hereby required to be levied shall be reduced
25 proportionately. The full faith and credit and unlimited taxing power of the County shall be

1 irrevocably pledged to the levy and collection of the taxes hereinabove prescribed as and when
2 such taxes may become necessary in order to provide sufficient funds to pay the principal of or
3 interest on such Notes.

4 If the County shall not, for any reason, issue and sell Metropolitan District Bonds in
5 anticipation of which any Notes may be issued, or if the proceeds from the sale of such Bonds shall
6 be insufficient to pay the principal of or interest on such Notes, then the principal of and interest
7 on such Notes shall be paid from time to time, as and when due, from the funds in the hands of the
8 County realized from the levy and collection of such special assessments and charges within the
9 Baltimore County Metropolitan District, including the special assessments and charges levied
10 against property benefited by construction undertaken with the proceeds of such Notes. In the
11 event of a deficiency of such funds at any time while any of such Notes are outstanding, for the
12 purpose of paying such principal and interest the County shall promptly levy upon all legally
13 assessable property within the Baltimore County Metropolitan District a tax or taxes in an amount
14 sufficient to make up any such deficiency; and in the event the proceeds of such tax or taxes so
15 levied shall prove insufficient, the County shall levy a tax or taxes upon all of the legally assessable
16 property within the entire corporate limits of the County in rate and amount sufficient to provide
17 for payment of the balance of such principal and interest. The full faith and credit and unlimited
18 taxing power of the County are hereby irrevocably pledged to the levy and collection of such
19 special assessments and charges in amounts sufficient for the purpose of paying such principal and
20 interest and also to the levy and collection of the taxes hereinabove prescribed as and when such
21 taxes may become necessary in order to provide sufficient funds to pay the principal of and interest
22 on such Notes.

1 To the extent permitted by law, interest on the Notes hereby authorized may be capitalized
2 and paid from the proceeds of the sale of such Notes or from the proceeds of the sale of the Bonds
3 in anticipation of the sale of which such Notes are issued.

4 SECTION 31. The Director of Budget and Finance shall separately account for proceeds
5 of the Bonds in anticipation of which any outstanding Notes shall have been issued on the date
6 that such Bonds are delivered in exchange for the purchase price thereof (the “Delivery Date”) and
7 shall credit to such account (i) cash in an amount equal to the principal of such Notes or (ii) direct
8 obligations of, or obligations the payment of which is unconditionally guaranteed by, the United
9 States of America (“Government Obligations”), the principal of and interest on which will be
10 sufficient without reinvestment to pay in a timely manner the principal or redemption price of such
11 Notes when due. The Director of Budget and Finance is hereby irrevocably directed to apply such
12 cash or the proceeds of such obligations to the payment of the principal of such Notes when due.

13 On the Delivery Date, the Director of Budget and Finance shall also deposit to such account
14 (i) cash in an amount equal to the interest becoming due on such Notes on or prior to the maturity
15 or redemption date of such Notes or (ii) Government Obligations the principal of and interest on
16 which will be sufficient without reinvestment to pay when due the interest becoming due on such
17 Notes on or prior to the maturity or redemption date of such Notes.

18 The County may provide any cash or obligations required to be deposited to provide for
19 the payment of principal or interest on any such Notes under this Section from the proceeds of the
20 sale such Bonds available for that purpose or from any other funds legally available for such
21 purpose.

22 Notwithstanding the foregoing, if the Delivery Date and the date on which the such Notes
23 mature or are to be redeemed are in different fiscal years and provision for the payment of the
24 interest on such Notes is the fiscal year in which such Notes mature or are to be redeemed has been

1 made in a budget submitted to the County Council prior to the Delivery Date (whether or not
2 money for the payment of such interest has been finally appropriated as of the Delivery Date), in
3 lieu of the deposit of such cash or obligations for the payment of interest on such Notes for any
4 period after the last day of the then-current fiscal year, the County Executive or the Director of
5 Budget and Finance may deliver a certificate on the Delivery Date of the Bonds stating that funds
6 sufficient to pay the interest on such Notes have been included in the budget for the next
7 succeeding fiscal year.

8 SECTION 32. The proceeds of Notes issued pursuant to this Ordinance may be used to
9 pay, at maturity, or at the time of redemption, the principal or redemption price of, or the principal
10 or redemption price of and interest on, Notes (“Refinanced Notes”) previously issued pursuant to
11 this Ordinance. If, and to the extent that, the proceeds from the issuance and sale of Notes are used
12 to repay the principal of Refinanced Notes, such Notes shall constitute a continuance and
13 reissuance of the indebtedness represented by the Refinanced Notes and authorized by this
14 Ordinance and shall not constitute additional indebtedness hereunder or under any other authority.

15 SECTION 33. Section 19-207 of the Local Government Article (the “Refunding Act”)
16 provides that refunding bonds may be issued by the County thereunder for certain public purposes
17 specified therein, including realizing savings to the County in the total cost of debt service on
18 either a direct comparison or present value basis.

19 The County Council hereby finds and determines that the issuance of Refunding Bonds
20 pursuant to this Ordinance in order to refund all or a portion of the outstanding principal amount
21 of any Refunded Bonds as herein provided will effectuate and accomplish the public purpose of
22 realizing savings to the County in the aggregate cost of debt service on both a direct comparison
23 and a present value basis.

1 SECTION 34. Pursuant to the Refunding Act, Section 10-203 of the Local Government
2 Article, the County Charter and certain other authority pursuant to which the Refunded
3 Consolidated Public Improvement Bonds (hereinafter defined) were issued, the County is hereby
4 authorized, upon its full faith and credit, to borrow money and incur indebtedness evidenced by
5 Bonds issued under this Ordinance (“Refunding Consolidated Public Improvement Bonds”) to
6 refinance (i) bonds of the County of the series, dated the dates, of the maturities and in the
7 aggregate principal amounts shown on Chart II attached hereto and (ii) Consolidated Public
8 Improvement Bonds issued hereunder that are subject to optional redemption (collectively,
9 “Refunded Consolidated Public Improvement Bonds”), subject to the provisions of this Ordinance.

10 SECTION 35. Pursuant to the Refunding Act, Section 10-203 of the Local Government
11 Article, the County Charter, Chapter 539 and certain other authority pursuant to which the
12 Refunded Metropolitan District Bonds (hereinafter defined) were issued, the County is hereby
13 authorized, upon its full faith and credit, to borrow money and incur indebtedness evidenced by
14 Bonds issued under this Ordinance (“Refunding Metropolitan District Bonds”) to refinance (i)
15 bonds of the County of the series, dated the dates, of the maturities and in the aggregate principal
16 amounts shown on Chart III attached hereto and (ii) Metropolitan District Bonds issued hereunder
17 that are subject to optional redemption (“Refunded Metropolitan District Bonds”), subject to the
18 provisions of this Ordinance.

19 SECTION 36. Refunding Consolidated Public Improvement Bonds and Refunding
20 Metropolitan District Bonds (collectively, “Refunding Bonds”) may be issued pursuant to this
21 Ordinance in an aggregate principal amount not to exceed 130% of the principal amount of the
22 Refunded Consolidated Public Improvement Bonds or Refunded Metropolitan District Bonds
23 (collectively, “Refunded Bonds”) refinanced thereby in order to provide funds sufficient (a) to
24 purchase Government Obligations, the principal of and interest on which will be sufficient without

1 reinvestment to pay in a timely manner all or any part of the principal of and redemption premium,
2 if any, and interest on such Refunded Bonds and, if so provided by order of the County Executive
3 issued pursuant to Section 12 of this Ordinance, a portion of the interest on such Refunding Bonds,
4 and (b) to pay any and all other costs permitted to be paid from the proceeds of such Refunding
5 Bonds under the Refunding Act, including (without limitation) the costs of issuance of such
6 Refunding Bonds and applicable underwriting fees.

7 The rate or rates of interest payable on any series of Refunding Bonds sold pursuant to this
8 Ordinance shall not exceed the maximum interest rate, if any, specified by the County Council by
9 public local law to be payable on obligations of the County.

10 Except as otherwise expressly provided in this Ordinance, Refunding Bonds shall have the
11 terms and provisions determined in accordance with Sections 12 and 13, and the County Executive
12 is hereby authorized to make the determinations set forth therein with respect to any Refunding
13 Bonds; provided, however, that the issuance of such Refunding Bonds will effectuate and
14 accomplish the public purpose of realizing savings to the County in the aggregate cost of debt
15 service on both a direct comparison and a present value basis with respect to the portion of any
16 Refunded Bonds being refunded with proceeds of such Refunding Bonds.

17 The County Executive is hereby authorized to determine the form of any Refunding Bonds
18 issued hereunder. The execution and delivery of Refunding Bonds as herein provided shall be
19 conclusive evidence of the approval of the form of such Refunding Bonds on behalf of the County.

20 It is hereby determined that the projects financed or refinanced by the Refunded Bonds
21 refunded with proceeds of any Refunding Consolidated Public Improvement Bonds and Refunding
22 Metropolitan District Bonds have an average period of probable useful life that terminates not
23 earlier than the last day of the fiscal year of the County during which the Refunded Bonds would
24 have finally matured.

1 SECTION 37. Refunding Bonds hereby authorized may be sold for a price at, above or
2 below par, plus accrued interest to the date of delivery. Authority is hereby conferred on the
3 County Executive to sell any Refunding Bonds through a public sale or through a private
4 (negotiated) sale, without solicitation of competitive bids, as the County Executive, upon
5 consultation with the Director of Budget and Finance and the County’s Financial Advisor, shall
6 determine to be in the best interests of the County. Any sale of Refunding Bonds by private
7 negotiation is hereby determined to be for the County’s best interest.

8 If the County Executive shall determine in accordance with this Section that the best
9 interests of the County will be served by the sale of all or part of the Refunding Bonds at a public
10 sale through the solicitation of competitive bids, then the County Executive may sell such Bonds
11 in such manner in accordance with such procedures as shall be determined by the County
12 Executive.

13 Refunding Bonds issued hereunder are hereby specifically exempted from the provisions
14 of Sections 19-205 and 19-206 of the Local Government Article.

15 SECTION 38. In connection with the issuance of any Bonds or Notes pursuant to this
16 Ordinance, the County is hereby authorized to enter into one or more agreements as the County
17 Executive shall deem necessary or appropriate for the issuance, sale, delivery or security of such
18 Bonds or Notes, which may include (without limitation) (i) underwriting, purchase or placement
19 agreements for Bonds or Notes sold at private (negotiated) sale in accordance with the provisions
20 of this Ordinance; (ii) trust agreements with commercial banks or trust companies providing for
21 the issuance and security of such Bonds or Notes; (iii) any dealer, remarketing or similar
22 agreements providing for the placement or remarketing of such Bonds or Notes; (iv) agreements
23 providing for any credit or liquidity facilities supporting any Bonds or Notes; (v) agreements with
24 commercial banks or trust companies providing for the deposit of proceeds of any Bonds or Notes;

1 and (vi) agreements with fiscal agents providing for the issuance of Bonds or Notes, their
2 authentication, registration or payment or other similar services. Each such agreement shall be in
3 such form as shall be determined by the County Executive by order. The execution and delivery
4 of each such agreement by the County Executive shall be conclusive evidence of the approval of
5 the form of such agreement on behalf of the County.

6 SECTION 39. The County hereby solemnly covenants with each of the holders of any
7 Bonds, Notes and Installment Purchase Agreements, the interest on which is expected to be
8 excludable from federal income taxation (such Bonds, Notes and Installment Purchase Agreements
9 being referred to herein collectively as “Tax-Exempt Obligations”), that it will not use, or suffer
10 or permit to be used, the proceeds received from sale of such Tax-Exempt Obligations, or any
11 moneys on deposit to the credit of any account of the County which may be deemed to be proceeds
12 of such Tax-Exempt Obligations, pursuant to Section 148 of the Internal Revenue Code of 1986,
13 as amended (the “Code”), and applicable regulations thereunder, which use would cause such Tax-
14 Exempt Obligations to be “arbitrage bonds” within the meaning of Section 148 of the Code and
15 the regulations thereunder. The County further solemnly covenants that it will comply with
16 Section 148 of the Code and the regulations thereunder which are applicable to such Tax-Exempt
17 Obligations on the date of issuance of such Tax-Exempt Obligations and which may subsequently
18 lawfully be made applicable to such Tax-Exempt Obligations. The County Executive, the County
19 Administrative Officer and the Director of Budget and Finance shall be officers of the County
20 responsible for issuing any Tax-Exempt Obligation. The County Executive or the Director of
21 Budget and Finance is hereby authorized and directed to prepare or cause to be prepared and to
22 execute, any certification, opinion or other document which may be required to assure that such
23 Tax-Exempt Obligations will not be deemed to be “arbitrage bonds” within the meaning of Section
24 148 of the Code and the regulations thereunder.

1 The County is hereby authorized to take any and all actions as may be necessary or
2 desirable to assure that interest on Tax-Exempt Obligations be and remain excludable from gross
3 income for federal income tax purposes.

4 The County is hereby authorized to take any and all actions as may be necessary or
5 desirable to assure that any Bonds, Notes or Installment Purchase Agreements authorized by this
6 Ordinance are allowed a tax credit, that the County is entitled to a subsidy from the United States
7 of America or any agency or instrumentality thereof with respect to such Bonds, Notes or
8 Installment Purchase Agreements or the interest payable thereon, or that any such Bond, Note or
9 Installment Purchase Agreements or the interest thereon is entitled to any other available benefits
10 under the Code (any such Bonds, Notes or Installment Purchase Agreements being referred to
11 herein as “Tax Advantaged Obligations”). Any such actions may be authorized by an order of the
12 County Executive.

13 The County Executive is hereby authorized to make such covenants or agreements in
14 connection with the issuance of any Tax-Exempt Obligations or Tax Advantaged Obligations as
15 he shall deem advisable in order to assure (i) the holders of any such Tax-Exempt Obligations that
16 interest thereon shall be and remain exempt from federal income taxation, (ii) the holders of any
17 such Tax Advantaged Obligations that such Tax Advantaged Obligations will be entitled to such
18 benefits, and (iii) that the County is entitled to any subsidy available for any such Tax Advantaged
19 Obligations. Such covenants or agreements shall be binding on the County so long as the
20 observance by the County of any such covenants or agreements is necessary in connection with
21 the maintenance of the exemption from federal income taxation of the interest on such Tax-Exempt
22 Obligations or the entitlement of such Tax Advantaged Obligations to such benefits, respectively.
23 The foregoing covenants and agreements may include (without limitation) covenants or
24 agreements on behalf of the County relating to the investment of proceeds of such Tax-Exempt

1 Obligations or Tax Advantaged Obligations, the rebate of certain earnings resulting from such
2 investment to the United States of America (or the payment of penalties in lieu of such rebate),
3 limitations on the times within which, and the purposes for which, such proceeds may be expended
4 or the utilization of specified procedures for accounting for and segregating such proceeds. Any
5 covenant or agreement made by the County Executive pursuant to this paragraph in an order or
6 certificate executed by the County Executive shall be binding upon the County.

7 In furtherance of the foregoing, in order to qualify for and maintain the tax-exempt status
8 of any Tax-Exempt Obligations or the benefits inuring with respect to any Tax Advantaged
9 Obligation, the County Executive shall be authorized to make any elections or designations
10 permitted or required under the Code, to apply for an allocation from the State of Maryland or the
11 federal government in the case of Bonds, Notes or Installment Purchase Agreements subject to any
12 volume limitation and to apply for any tax credit, to take such actions as shall be necessary to
13 permit any tax credit to be stripped and sold separately from the ownership interest in any Tax
14 Advantaged Bond and to claim any cash subsidy with respect to any Tax Advantaged Obligation.
15 It is confirmed that the County Executive is authorized to declare official intent to reimburse
16 expenditures from proceeds of Tax Advantaged Obligations.

17 For purposes of establishing compliance with Section 148 of the Code regarding the
18 expenditure of proceeds of Tax-Exempt Obligations or Tax Advantaged Obligations, the source
19 of General Fund monies for capital expenditures may be specifically attributed to funds deposited
20 to the General Fund as a reimbursement from the proceeds of County debt issuances in accordance
21 with a certificate executed by the County Executive.

22 Tax Advantaged Obligations may be issued pursuant to Section 19-208 of the Local
23 Government Article or any other laws of the State of Maryland authorizing the issuance thereof
24 and may be sold for a price at, above or below par, plus accrued interest to the date of delivery.

1 Authority is hereby conferred on the County Executive to sell any such Tax Advantaged
2 Obligations through a public sale or through a private (negotiated) sale, without solicitation of
3 competitive bids, as the County Executive, upon consultation with the Director of Budget and
4 Finance and the County's Financial Advisor, shall determine to be in the best interests of the
5 County. Any sale of Tax Advantaged Obligations hereunder by private negotiation is hereby
6 determined to be for the County's best interest. Tax Advantaged Obligations issued hereunder are
7 hereby specifically exempted from the provisions of Sections 19-205 and 19-206 of the Local
8 Government Article.

9 It is recognized that the market for Tax Advantaged Obligations is evolving and that the
10 issuance and sale from time to time of Tax Advantaged Obligations with one stated maturity may
11 be the most practicable method for successfully accomplishing the sale of Tax Advantaged
12 Obligations by the County. Accordingly, the County is hereby authorized to issue Tax Advantaged
13 Obligations with a single stated maturity and to provide for an annual installment plan (the
14 "Installment Plan") with respect to the payment of Tax Advantaged Obligations, such Installment
15 Plan to be approved by an order of the County Executive. The Installment Plan shall provide for
16 annual payments to a sinking fund account (the "Escrow Account") to be pledged to the payment
17 of the Tax Advantaged Obligations and to be held by a trust company or other banking institution,
18 as trustee or escrow agent, such annual payments to commence not later than two years from the
19 date of issuance of the Tax Advantaged Obligations. Amounts so deposited to the Escrow Account
20 shall be invested and reinvested in direct obligations of, or obligations the principal of, and the
21 interest on which, are guaranteed by, the United States of America, or in certificates of deposit or
22 time deposits secured by direct obligations or obligations the principal of, and the interest on
23 which, are guaranteed by, the United States of America. Each annual payment deposited to the
24 Escrow Account under the Installment Plan shall be invested and reinvested in a manner
25 determined by the County so as to provide for the payment of a portion of the stated principal

1 amount of such Tax Advantaged Obligations and related interest, if any. The issuance and sale of
2 Tax Advantaged Obligations as a single bond with one stated maturity and the establishment of an
3 Installment Plan as herein described are hereby authorized notwithstanding the requirement in
4 Section 12 of this Ordinance that Bonds be issued as serial maturity bonds or term bonds having
5 mandatory sinking fund requirements, with principal installments commencing not more than two
6 years from the date of issuance of the Bonds.

7 It is confirmed that bond premium, consisting of net bond proceeds from the sale of bonds
8 sold at a price above par, may be allocated for expenditure purposes permitted under provisions of
9 federal income tax law pertaining to excludability of interest on the bonds from gross income or
10 the tax status of Tax Advantaged Obligations, as applicable.

11 The County may determine to issue Bonds, Notes and Installment Purchase Agreements
12 with the expectation that any such indebtedness will not constitute a Tax-Exempt Obligation or a
13 Tax Advantaged Obligation.

14 SECTION 40. Not more than 30 and not less than 15 days prior to the date established by
15 the County Executive for the sale of any Bonds, the County Executive shall give to members of
16 the County Council at their offices in the Historic Court House written notice of the date
17 established for the sale of such Bonds, the estimated aggregate principal amount of such Bonds,
18 the purposes for which such Bonds are being issued, the estimated dates on which such Bonds
19 mature and the estimated amount maturing on each such date and any applicable redemption
20 provisions pertaining to the Bonds. The failure of the County Executive to give such notice, or
21 any defect in such notice, shall not affect the validity of the Bonds, the sale of the Bonds or any
22 proceedings relating thereto.

23 SECTION 41. Except as provided in the further provisions of this Section, the authority
24 to issue Bonds and Notes pursuant to this Ordinance shall expire on December 31, 2019 (the

1 “Expiration Date”). The expiration of the authority to issue Bonds and Notes pursuant to this
2 Ordinance as aforesaid shall not affect the authority of the County to issue bonds and incur
3 indebtedness pursuant to the Borrowing Plan Ordinances hereinabove set forth, nor the validity of
4 any Bonds or Notes issued prior to the Expiration Date and outstanding on or after such Expiration
5 Date.

6 (a) The authority to issue Refunding Bonds and Bonds to be sold to the Water
7 Quality Administration pursuant to this Ordinance shall not expire on the Expiration Date.

8 (b) The authority to issue Bonds and Notes pursuant to this Ordinance shall not
9 expire on the Expiration Date with respect to Bonds or Notes issued to: (1) refund Notes
10 outstanding on the Expiration Date; or (2) refund Notes issued to refund, directly or through a
11 series of refundings, Notes outstanding on the Expiration Date.

12 (c) The authority to incur indebtedness by the execution and delivery of
13 Installment Purchase Agreements pursuant to this Ordinance shall not expire on the Expiration
14 Date.

15 SECTION 42. In accordance with the provisions of Article IV, Section 402(d)(16) of the
16 County Charter, the County Executive is hereby authorized to delegate to the County
17 Administrative Officer the power and authority to take any and all actions required or permitted to
18 be taken by the County Executive pursuant to this Ordinance.

19 SECTION 43. If any one or more of the provisions of this Ordinance, including any
20 covenants or agreements provided herein on the part of the County to be performed, should be
21 contrary to law, then such provision or provisions shall be null and void and shall in no way affect
22 the validity of the other provisions of this Ordinance or of the Bonds, the Notes or the Installment
23 Purchase Agreements.

1 SECTION 44. This Ordinance shall take effect forty-five (45) days from the date of its
2 enactment.
