FOR the purpose of amending the 2018-2019 Capital Budget, by appropriating \$170,242,761  
as authorized in Bills 41-18, 44-18, 43-18, and 37-18.

County Council may, upon recommendation of the County Executive, amend the Capital Budget;

WHEREAS, in accordance with Sections 705 and 718 of the Baltimore County Charter, the voters of the county approved the borrowing authorized under Bills 41-18, 44-18, 43-18, and 37-18; now, therefore;

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Section 716  
3 of the Baltimore County Charter that the Capital Budget for the fiscal year ending June 30, 2019,  
4 be and is hereby amended by appropriating in the amount herein specified to the following  
5 projects:
