FOR the purpose of establishing the Baltimore County Behavioral Health Advisory Council; providing for the duties and membership of the Council; providing for the terms of the members; requiring the Behavioral Health Advisory Council to appoint the chair and vice chair of the Behavioral Health Advisory Council; authorizing the Behavioral Health Advisory Council to adopt certain procedures; requiring the Behavioral Health Advisory Council to meet at least a certain number of times a year; providing that a member may not receive compensation as a member of the Behavioral Health Advisory Council but is entitled to certain reimbursement for expenses; requiring the Health Officer or Bureau of Behavioral Health to provide certain staff for the Behavioral Health Advisory Council; merging the Baltimore County Mental Health Advisory Council into the Behavioral Health Advisory Council pursuant to §10-309(c) of the Health-General Article of the
