**ARTICLES OF ORGANIZATION
OF

The undersigned, being authorized to execute and file these Articles of Organization for record with the Maryland State Department of Assessments and Taxation, hereby certifies that:

FIRST: The name of the limited liability company (hereinafter referred to as Company") is "Woodensburg Land and Cattle Company, LLC".

SECOND: The object and purpose for which, and for any of which this Company is formed and the business to be carried on or promoted by it are to do any or all of the following things:

(A) To conduct business in any state for any lawful purpose to the fullest extent set forth in § 4A-201 of the Corporations and Associations Article of the Annotated Code of Maryland, as amended from time to time (the "Code").

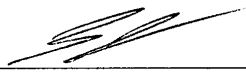
(B) To hold, manage, operate, lease, develop, finance, and sell real property.
