ENTITLED

AN ACT concerning

B.L. Zone – Permitted Uses

FOR the purpose of permitting a candy store located in a B.L. Zone to sell certain goods by internet sales; and generally relating to permitted uses in the B.L. Zone.

BY repealing and re-enacting, with amendments

Section 230.1.A.9.
Baltimore County Zoning Regulations, as amended

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

1 Section 230. Business, Local (B.L.) Zone Use Regulations

2 230.1. Permitted uses.

3 A. The following uses only are permitted (see Section 230.2):

5 Alcoholic beverage package store

6 Amusement devices, subject to the provisions of Section 422

7 Animal grooming facility

8 Antique shop

9 Arcade, subject to the provisions of Section 423. A

10 Automobile accessory shop

11 Automobile parking lot

12 Bakery, but goods baked on the premises must be sold only at retail on the premises,
13 except that wholesale operations are permitted if the bakery is located in a commercial
14 revitalization district and if the retail component of the bakery fronts the street and the
15 wholesale operations are limited to no more than 30% of the building's square footage

16 Barbershops and beauty shops

17 Billiard and pool rooms

18 Bowling alley

19 Camera, photo-supply or film-processing shops or pickup stations (including "drive-by"
20 facilities)

21 Candy store, but goods made on the premises must be sold only at retail on the premises,
22 **EXCEPT THAT RETAIL SALES MAY BE SUPPLEMENTED WITH INTERNET**
23 **SALES PROVIDED THAT THE RETAIL COMPONENT OF THE STORE FRONTS**
24 **THE STREET**

26 Commercial film production, subject to Section 435

- 25 for the premises, showing the sales area and the dates on which flowers or plants are to be
- 26 sold. Any provision of these regulations to the contrary notwithstanding, the Zoning
- 27 Commissioner's approval of such a license shall expire one year after its issuance;
- 28 however, such a license may be reappraised annually upon request of the licensee

- 5 Wireless telecommunications antennas or wireless telecommunications towers, subject to
- 6 Section 426.

7 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
8 the affirmative vote of five members of the County Council, shall take effect on March 1, 2013.
